In the case of any internal or external event, an initial risk assessment is conducted by the appropriate Booking Authority (individuals or departments who oversee scheduling and space bookings) within the College. Where an event requires additional approval from the Department of Public Safety and Emergency Management, Department of Capital Development and Facilities Management, Student Services, the Office of Legal and Risk Management, or another College office/department, the Booking Authority will ensure the required approvals have been obtained by the Applicant. If additional security or safety measures are required to host the event and mitigate additional risks and concerns, the Department of Public Safety and the Booking Authority will work with the party interested in hosting the event to communicate the need and, if necessary, related additional costs, etc. in advance of approving the event. During the reporting period there were no instances where a non-curricular event did not proceed due to security concerns or their related costs.

# **Complaints**

Between August 1, 2023 and July 31, 2024, one official/formal complaint was made by a member of the institutional community (or guests) about free speech.

Total: 1408 (1103 non-curricular events and 305 Varsity games). This information contains both in-person and virtual events.

## Additional Comments or Notes:

On November 01, 2023 stickers were reported posted around the Lakeshore Campus with the words "Boycott Israeli Apartheid". The individual responsible was later identified as a student and temporarily trespassed for violating Humber's Posting Policy. The posters were removed, and the individual was advised a few hours later that they were welcome to return to campus and informed of the Posting Policy of Humber College. This community member protested that the removal from class was a violation of freedom of expression. In response to the concern, the student met with the Associate Vice President, Learner and Career Success and Dean of Students (Dean of Students) and shared their experience. The Dean of Students indicated that the College is committed to Freedom of Expression and made a further commitment to approach similar situations differently in the future. On November 07, 2023 a protest in response to the war in Israel and Gaza and the above-mentioned incident was organized at the Lakeshore Campus. The protest was conducted safely and there were no complaints related to it.
