Integrated Accessibility Standards - 2013 Requirements Update

Jessica Bowen shared with Committee members the AODA requirements for Humber for 2013.

- Humber is required to develop and maintain a multi-year accessibility plan that outlines how it will meet the requirements outlined within each accessibility standard. Members were provided with a draft of the plan and were requested to provide feedback on the document. Members' suggestions, feedback, and additions were incorporated into the document.
- Humber must begin incorporating accessibility criteria and features when it procures or acquires goods, services and facilities. Humber's Purchasing Policy has been revised and includes statement on Humber's commitment to accessible procurement practices.
- Humber is required to develop an Accessibility Policy and an Organizational Statement
 of Commitment to People with Disabilities. Both documents are currently involved in the
 consultation process and will be provided to Committee members for review and
 feedback in the coming weeks.
- Humber is currently developing a training module to fulfill its AODA requirement of providing Accessibility Awareness Training to Educators. More information about the training module and content will be provided during the next AODA Committee meeting.
